

HOUSE RULES

Welcome to our campus pubs, operated by the Students for the College Community; which consists of students, staff and alumni. Our goal is to provide a friendly atmosphere with courteous and efficient service, beverages, and entertainment at a reasonable cost. However, in keeping with the spirit of friendship, we, as the licensee, understand that we have additional responsibilities. We fully support the practice of responsible beverage service and place the safety and well-being of our patrons as our first priority. We are not responsible for lost or stolen items in our establishments.

ADMITTANCE OF PATRONS

- Admission is restricted to Sheridan students, staff, faculty (with valid college staff ID), alumni and their guests. Guests must be signed in and out by the Sheridan student, as well as arrive and leave with the same Sheridan student.
- A valid Sheridan OneCard or Alumni Card is required at all times to gain access. Students with valid OneCards are permitted 1 non-student guest (when applicable); guest must be 19+.
- Non-Sheridan guest ID information will be recorded as per our privacy policy listed at www.thessu.ca.
- Guests refusing to have their information recorded will not be permitted to enter.
- Sheridan students & staff will be held responsible for the actions of their guests.
- We reserve the right to ask for a student card/photo I.D at any time when in our facilities.
- All Patrons will be required to present two forms of Alcohol and Gaming Commission of Ontario (AGCO) approved photo ID to enter. Those forms of ID are "Ontario Driver's Licence", "Canadian Passport", "Country Issued Passport", "Canadian Citizenship Card", "Canadian Armed Forces Identification Card", "Bring Your Identification (BYID) Card", and "Liquor Licence Board of Ontario ID Card". IDs must be valid and in its original form, no photos or (digital) copies will be accepted.
- Re-entries will not be permitted at any time. All Patrons who leave are not permitted re-entry during event nights
- All patrons that enter the premises may be subject to a search by security (i.e. bag, coat or body)
- Management reserves the right to deny entry to anyone at any time.

COAT/BAG CHECK

- Coat and bag check is mandatory – and FREE.
- In order to claim items at Coat Check, the patron must present a coat check ticket.
- If a patron loses their coat check ticket, they must wait until the end of the night when all other items have been claimed, in order to claim their checked items.
- SSUI is not responsible for lost or stolen items

VANDALISM

Damage or destruction of Student Union Building or property is considered vandalism. Anyone participating in such vandalism or other criminal activity will be removed from the premises, may be prosecuted to the fullest extent of the law and required to pay for all damages in full including an administrative charge if applicable

AGCO LAWS & REGULATIONS

- Underage drinking will not be tolerated and is against the Liquor License Act; it may result in sanctions as per the Student Code of Conduct.
- We reserve the right to refuse entry or service to any patron when deemed intoxicated or a threat to the well being of the operation.
- All persons who appear to be intoxicated are prohibited from entering or remaining in the establishment. When possible, pub staff will endeavor to ensure that safe transportation home has been arranged for the intoxicated patron.
- Alcoholic beverages are not permitted in the bathrooms or outside of licensed areas.
- There will be a 2-drink maximum per patron, at a time.
- Alcoholic beverages purchased in establishment must remain on premises.
- No outside alcohol is permitted at this establishment or on establishment property.
- Last call at the bar can be called at anytime but no later than 2:00am at which time no alcoholic beverages will be served.

CODE OF CONDUCT

- All patrons must adhere to Sheridan's Student Code of Conduct.
- Aggressive behavior or conduct perceived dangerous to the safety of other patrons or staff will not be permitted.
- Physical, verbal, or sexual harassment of employees or patrons will not be tolerated.
- In the event of any problem involving patrons, photo IDs must be surrendered upon request of the staff / security
- Door closing time is up to the discretion of the Manager on site. No admittance will be granted after that point in time.
- Altercations will result in equal dismissal of both parties involved in the incident.
- Any person who does not leave the premises immediately, or re-enters after being asked, will be charged with trespassing and prosecuted to the best of our abilities.
- Drug use on premise will result in removal from the establishment.
- Unlawful gaming, gambling or betting is prohibited as per AGCO Laws.
- No weapons or fireworks allowed.
- Smoking and vaping are not permitted in the establishment or on campus at anytime; all smoking and vaping paraphernalia MUST be checked at coat check and can be claimed before leaving the premises.
- No soliciting allowed on premises unless previously approved by Student Union.
- Photography and videotaping is not permitted unless approved by Management.
- All violations of the Code of Conduct will be sent to the rights and responsibility for review.

Any patron who does not abide by the "House Rules" will have their privileges revoked and are subject to further consequences. Any guest caught with drugs, weapons, or counterfeit ID or currency will be immediately reported to police and/or campus security.

Violation of any of the above rules will result in being banned automatically for one year from all Sheridan Student Union events and the possibility of Non-Academic Probation for a period determined by Sheridan College.
